COMMITTEE REPORTS

Summer Brown reported for zoning that the Moraine Sands Wind Project hearings went well with little objection. Brown also reported that our new Code Enforcement Officer, Gage Shawgo, still has training to complete and is doing an excellent job settling into his position.

Mr. Eldon Garlisch reported for the License/Animal Control Committee that Community Action has hired Jennifer Deweese and she will start on May 1st.

Bill Parsley reported for Building & Grounds that we will be implementing the bid process for the new roof on the jail soon. He also reported that we are still waiting on all of the HVAC proposals.

Dorothy Kreiling reported the following for Emergency Services Committee. The Health Department is offering second boosters for ages 50 and over and the vaccine for 5-11 years old is also available by walk-in. Community clinics are ongoing in Manito and San Jose. The hospital is still testing for covid and also has many open positions available. Kreiling noted that the EMA is rewriting their manual and has met with the dive team about certifications. Two "new to us" squad cars are ready for use. Kreiling stated that the Sheriff's department is only responding to priority calls due to gas prices. There has been an uptick in crime with lots of catalytic converters being taken.

Ron Knollenberg reported for the Finance Committee that the audit is still ongoing. Summer Brown indicated that it could be a while because of the single audit.

Hugh McHarry reported for the Special Problems Committee that he hopes we can find ways to replace the power plant revenue. McHarry mentioned that there are lots of questions about the battery storage business moving to the power plant area. He is hopeful that the county, city and townships will all welcome possible incoming solar farms.

Summer Brown reported that Amanda Pankau, who is a representative from Illinois Prairie River, will meet with districts affected by the power plant closure at the City Center on Tuesday, April 19, 2022 at 10:00 am. Her plan is to provide information about grants that will be available and to draft a letter to send to the DCEO. Brown also reported that the current electric rate through Energy Aggregation expires in June and that Chairman Walker has been designated to sign a new agreement for the surrounding areas. The term will be different this time. Brown reminded everyone that the primary is underway in her office and that she is wrapping up the tax extension.
